

Terms and Conditions

1. Introduction

- 1.1. This web site, <u>www.athruassure.com</u>, (the "Site") is owned and operated by Athrú Solutions Proprietary Limited, a company registered in South Africa with company registration number 2022/619598/07 (hereinafter referred to as "Athrú")
- 1.2. The following terms and conditions, which include reference to Athrú's Privacy Statement applicable to the user's usage of the interaction with the Site, (hereinafter the "T's & C's") govern the relationship between the user and Athrú in the use of the Site. (2) The only charge that may be levied on the consumer is the direct cost of returning the goods. (3) If payment for the goods or service has been effected prior to a consumer exercising a right referred to in subsection (1), the consumer is entitled to a full refund of such payment, which refund must be made within 30 days of the date of cancellation. (4) This section must not be construed as prejudicing the rights of a consumer provided for in any other law."

12. General

- 12.1. These T's & C's constitute the sole record of the agreement between you and Athrú in relation to the subject matter hereof. Neither you nor Athrú shall be bound by any express, tacit or implied representation, warranty, promise or the like not recorded herein. These terms and conditions supersede and replace all prior commitments, undertakings or representations, whether written or oral, between you and Athrú in respect of the subject matter hereof. No addition to, variation or agreed cancellation of any provision of these terms of use shall be binding upon Athrú unless agreed to in writing by Athrú. No indulgence or extension of time which Athrú may grant to you will constitute a waiver of or, whether by estoppel or otherwise, limit any of the existing or future rights of Athrú in terms hereof, save in the event or the extent that Athrú has signed a written document expressly waiving or limiting such rights.

 - b. Performance cookies: Performance cookies collect information about how you use the Site so we can improve them for you in the future. For example, they collect information on which pages you visit most often and any error messages you may get. The information collected by these cookies is anonymous. They do not collect any information that can identify you personally.
 - c. **Functionality cookies:** Functionality cookies enable us to provide you with a more personalised experience. They help us to remember data, such as your username and language preference, to save you having to enter them again the next time you visit. The information these cookies collect is anonymous. They cannot track your browsing activity on other websites.
 - d. **Targeting/advertising cookies:** Athrú and our service providers may use advertising cookies to deliver ads that we believe are relevant to you and your interests. For example, we may use targeting or advertising cookies to customise the advertising and content you receive on the Sites, to limit the number of times you see the same ad on the Site and to help measure the effectiveness of our advertising campaigns.
